



*Stallion Breeding Contract – Live Cover*  
*2020 Breeding Season (Feb. 14<sup>th</sup> – July 31<sup>st</sup>)*

Subject to the following conditions:

1. The breeding fee for stallion is \$400.00, of which \$50.00 shall be payable at time of the execution of this contract as a booking fee. Said booking fee serves as a non-refundable deposit. This booking fee may not be transferred to another mare owner or carried forward to a different breeding season. If received with paid booking fee before January 1<sup>st</sup> 2020 a discount \$50 will be given for early booking.
2. The breeding fee balance of \$350.00 together with unpaid board and expenses pertaining to said Mare, will be due and payable at the time said Mare leaves Lazy Three Bar Ranch. The Mare will not be released to the Mare Owner or his/her representative until all fees are paid in full.
3. Breeder will exercise judgment consistent with recognized standards in the care and supervision of Mare and/or any accompanying foal while in custody. Board for said Mare shall be as follows: \$8.00 per day for dry mare, \$10.00 per day for wet mare, board fee 50% off if Mare Owner provides feed.
4. Mares offered for breeding must be bare foot or front shoes only. If the mare arrives with back shoes they will be pulled prior to breeding and there will be an additional \$15 charge.

5. Mare Owner's will incur an additional handling charge, minimum of \$5 per event for any extra handling such as medication given, hold for the farrier, or trailering to the vet for exams.
6. Breeder assumes responsibility for arranging veterinarian and farrier services as necessary. Breeder's veterinarian will examine mare for normal breeding conditions and administer medical care as deemed necessary for the health and safety of the mare and/ or accompanying foal. All veterinarian and farrier expenses will be paid by Mare Owner.
7. Mares must be halter broke and manageable. In the event that said Mare attempts to kick Stallion during breeding, suitable restraints will be utilized. If the breeding cannot be accomplished safely, the mare will not be bred. Options for Artificial Insemination will be available. Mares that are not halter broke will not be accepted. Mares that the Breeder deems unsafe are not accepted. The Mare Owner will be notified immediately and said Mare will be picked up from Lazy Three Bar Ranch within 24 hours unless other arrangements have been made.
8. Mare Owner shall agree that the Mare offered for breeding shall be in sound breeding condition and free from all infections, contagious or transmissible diseases. If the Mare offered does not settle after 2 cycles L3B requires said Mare to have a full reproductive exam.

The following documents shall be furnished to Breeder upon Mare's arrival at Lazy Three Bar Ranch:

- A photostatic copy of Mare's registration papers (both sides) Note: If mare is leased a copy of the AQHA, APHA or appropriate association lease agreement must be attached.
- A current negative Coggins Test (out of state mares only)
- Veterinarians health certificate (out of state mares only)

If said documents do not accompany mare Breeder's veterinarian will examine and/or test mare at Mare Owner's expense. Breeder reserves the right to refuse mare and/or accompanying foal if not in satisfactory condition. If mare is refused the Mare Owner may substitute another mare within that breeding season.

9. Breeder agrees to diligently try and settle Mare and shall have sole discretion in determining the best method of breeding such Mare. The Mare Owner agrees to give Breeder ample time to settle mare. If for any reason the mare does not settle rebreed privileges will be available.
  - Lazy Three Bar Ranch must be allowed to have at minimum two (2) active cycles to settle the Mare.
  - If the mare is picked up while actively cycling, preventing the breeder from having ample time to settle Mare the LFG becomes null and void.
10. Rebreed privileges are for the following year only. The breeding fee will not be refunded. If Mare Owner fails to return the following year, then any and all fees paid shall be forfeited, the right to rebreed is canceled and Breeder is released from all obligations of this contract.

11. Live Foal Guarantee. A live foal is described as a newborn foal that stands and nurses without assistances and survives the first 48 hours. If the mare does not settle, aborts her foal, the foal is stillborn, or said foal does not survive longer than 48 hours, rebreed privileges are guaranteed only for the following year.

LFG will be void if the Mare Owner does not comply with the following:

- Ultrasound to confirm mares pregnancy by a licensed veterinarian is required by September 30th of the current breeding year.
- The Mare Owner should inform us within 30 days after the mare has been proven open via ultrasound by a licensed veterinarian.
- The Mare Owner should inform us within 7 days after labor that the Mare did not produce a live foal. Proper notification shall be defined as written certification by a licensed veterinarian or a photo confirming the Mare did not produce a live foal within 7 days from the date Mare lost her foal.
- Exception to this rule is if the mare is sold during gestation without informing the Breeder. If the breeder is informed, and does not see any problems, he/she will send a registered letter to the new owner to transfer the LFG to the Mare's new owner.
- This live foal guarantee shall not cover death of foal due to neglect or deliberate destruction except for humane euthanasia. If the veterinarian suggests in any way in his/her statement that the foal could have been viable, lived, and you choose to euthanize for any other reason other than a life-threatening injury or illness, the live foal guarantee will be null and void.
- Mare Owner agrees not to put the Mare back into race or performance training and events during any part of her gestation.
- Mare must not be exposed to any other Stallion 90 days before being exposed to above listed stallion nor be exposed to any Stallion up to 48 hours post foaling.
- Live foal guarantee will only cover first year re-breeds. Second year re-breeds will not have a live foal guarantee.
- Any request to utilize re-breeds must be received no later than March 30th of the following breeding year to guarantee a breeding. Requests received later than March 30th will be the sole discretion of Lazy Three Bar Ranch, in which we cannot guarantee a re-breed will be available due to short notice.

12. A Breeders Certificate shall be issued to Mare Owner only after Mare Owner has notified Breeder that said Mare has produced a live foal and only after payment of all bills due on said Mare have been received.

13. Waiver of liability. It is understood that Lazy Three Bar Ranch, its owners, employees, and guests shall not be held responsible for disease, accident, sickness or death of the Mare and or foal while under their care. The above named Mare Owner whose horse(s) are under the care of Lazy Three Bar Ranch will not be liable or responsible for any disease, accident, or injury to their stallions, mares, or foals.

14. If the above named stallion dies, becomes unfit for breeding or is sold, then this contract becomes null and void and both parties are relieved of any further obligation. Any money

paid by Mare Owner toward the breeding fee, with the exception of the non-refundable booking fee that is included, shall be refunded to the Mare Owner if the Mare is not settled, or would qualify for rebreed privileges or the Mare Owner may breed above named Mare to another Stallion that is agreed to by both the Mare Owner and Breeder.

15. If the above Mare dies or becomes unfit to breed, the Mare Owner may substitute a mare. Rebreed privileges will be available.

16. This Breeding Contract constitutes the entire agreement between the parties. No other agreements or promises, verbal or implied are included unless specifically stated in the written contract. Any amendments to or modifications of the terms of this agreement must be in writing.
